

IDSA FINANCIAL REGULATIONS

1. Annual membership fee for national IDSA member organization is 300 euro.
2. Annual membership fee for IDSA international member organization is 500 euro.
3. Annual membership fee for IDSA continental member organization is 700 euro.
4. Annual membership fee for international competitor is 60 euro.
5. Annual membership fee for international dance teacher is 80 euro.
6. Annual membership fee for international adjudicator is 100 euro.
7. Annual membership fee for international sport dances inspector is 100 euro.
8. Right of running of one program of one age group of IDSA title competition – 300 euro.
9. Right of running of IDSA rating competition for one day – 100 euro.
10. In case of cancellation of running the event due to any force majeure reasons, fee for the right of running shall not be refunded.
11. IDSA title calendar is formed for the period from 01st January till 31st December every year separately. If an event has not been held within 01st January - 31st December of the current year due to any force majeure reasons, fee for the right of running shall not be refunded.
12. Organizer of IDSA title event shall pay for the first couple from a country which is an active IDSA full member, 2 nights hotel accommodation with 3 meals per day and transfer airport-hotel-airport, without entry fee if this couple have valid IDSA competitor licenses. All other couples from this country are responsible for their own expenses, including transfers, meals, accommodation, and entry fees of 60 euro from one couple per one age group and one program.
13. Organizer of IDSA title event shall pay to nominated and approved adjudicator of IDSA title event economy class airfare, transfers airport-hotel-airport, judging fee of 200 euro per day as adjudicator of IDSA title event and 2 nights hotel accommodation with 3 meals per day. Such adjudicator must hold an active IDSA International dance teacher license and International adjudicator license.
14. Judging fee for one day of work for Chairman of IDSA title event– 300 euro.
15. Right of running of IDSA training camp for one day- 100 euro.
16. Annual membership fees to IDSA shall be paid until 01st of June of the current year for the following year.
17. IDSA adjudicator license is issued only based on active IDSA dance teacher license.
18. Rating and title IDSA competitions can be adjudicated only by adjudicators with active IDSA adjudicator license.
19. Only dance couples with active IDSA International Competitor license shall be admitted to IDSA rating and title competitions.
20. Registration fee at IDSA International and National title event from one dance couple in one program and in one age group – 60 euros. Registration for the title event is accomplished only based on full prepayment of the registration fee.
21. Registration fee at IDSA International and National title event from one solo girl in one program and in one age group – 60 euros. Registration for the title event is accomplished only based on full prepayment of the registration fee.
22. Registration fee at IDSA International and National title event from one solo boy in one program and in one age group – 60 euros. Registration for the title event is accomplished only based on full prepayment of the registration fee.
23. Registration fee at IDSA International and National title event in trio from one person in one program and in one age group – 60 euros. Registration for the title event is accomplished only based on full prepayment of the registration fee.
24. Registration fee at IDSA International and National title event in formation team from one couple in one program and in one age group – 60 euros. Registration for the title event is accomplished only based on full prepayment of the registration fee.
25. Registration fee at IDSA International and National title event in Pro-Am from one couple in one program and in one group – 200 euros, in one showcase- 300 euros, Pro-Am single dance: for each dance- 100 euros. Registration for the title event is accomplished only based on full prepayment of the registration fee.
26. If competitors, who have already paid the registration fee for any title event, fail to compete at the title event due to any force majeure reasons, registration fee shall not be refunded.
